One qualified physical director should be appointed. A qualified librarian should be appointed immediately.

All the staff members should possess at least the minimum qualification prescribed by the university, and be paid in accordance with the UGC scales of pay. Every member of the staff should enter into an agreement with the management as prescribed in the conditions of services of teachers in colleges.

The lecturer in history should be qualified to teach History to the B.A. Br. IV- Economics students.

- 4. LIBRURY: A sum of *s.2000/- as non-recurring and *s.1000, as recurring under each department should be provided towards the library. All the books suggested by the commissioners in English, Tamil, *conomics and Mathematics should be purchased* immediately. A few more journals may be added to the Economics department.
- 5. Hostel accommodation should be made available for at least 50% of the students.
- 6. A sum of R.5/= lakes should be provided as endowment of the college. The balance of endowment of R. 3/- lakes should be provided immediately. The details about the hostel which are proposed to be shown towards endowment should be furnished to the university before 31st August, 1970-

Your attention is invited to the 'Specific recommendation' of the report of Selvi Lucy Thomas (Convener) wherein she has stated regarding the appointment of staff and request you the defects pointed out by her.

A reply regarding appointment of staff, provision of funds towards library, endowment, etc. purchase of books and journals, number of students admitted etc. should be furnished by the end of this month viz. August, 1970.
