<u>V Students matter:</u> The college was closed on 24<sup>th</sup> March 2020 due to the Corona Pandemic. The University conducted the examinations online to the final year students. The UG I & II Year and PG I Year students were exempted from writing the university exams and they all declared as 'all Pass'. The admissions for the academic year 2020-21 was very slow, due do the economics strain faced by the parents. Any how our college able to fill- up an overall 86 percent of the seats sanctioned by the effort taken by the admission committee and Principal. The present strength of the college is 1233.

'Odd Semester' classes were conducted 'online' Our college is one of the very few colleges which conducted online classes perfectly as per the time table. The college activities / programs were also conducted online. The odd semester university Examinations were also conducted online. The even semester classes were started on 28<sup>th</sup> Dec. 2020. The final year students only permitted to come to college and the remaining students remained in home and attended online classes. After almost one year period of time since the college was closed due to pandemic regular classes for all the students started on 8<sup>th</sup> Feb. 2021.

**<u>IV College Development Matters</u>:** Even though the college was closed for nearly 9 months, the principal's office is very busy with students welfare, staff welfare and college developments.

#### **Building**

The Golden Jubilee Block was originally planned only ground and first floor. But realising the need of the hour, the office bearers of TND gave permission to construct the 2<sup>nd</sup> floor also. Now, the Golden Jubilee Block, the first two – storey building in the college at an estimate of 1.04 Crore Rupees is completed and dedicated today (18.02.2021) by our Bishop Iyya Rt. Rev. S.E.C. Devasagayam and opened by our dynamic Secretary, Nazareth Margoschis College Pillaiyanmanai & Lay Secretary TND in the presence of our collegiate education standing committee secretary Mr. J. Jebachandran. The Main Entrance Arch also completed and dedicated today I am proud to inform that a church at Arasarkulam Village in Palaniappapuram Pastorate sponsored by our staff members is also completed and the church is ready for dedication by our Bishop Iyya on 26<sup>th</sup> Feb. at 10:00 a.m. as the 50<sup>th</sup> church of TND 100 village church program. Taking this opportunity I thank all the members of staff who have contributed liberally towards the construction of the church. We thank our beloved Bishop Iyya and our secretary for recognising the church as the 50<sup>th</sup> church of this Program.

**NIRF & NAAC**: The Principal informed that the college has registered and data were submitted successfully for NIRF ranking process this year on 10<sup>th</sup> Feb. Further the AQAR report of NAAC for the completed years after NAAC accreditation is also ready and it will be sent before the end of this month.

**<u>Research Centre:</u>** The university has recognised our English department as research centre to pursue Ph.D. degree. Already the department of commerce and department of maths are Ph.D.

research centres. The department of English is the third Ph.D Research centre in our college. This will help the students in our area to peruse Ph.D in our college itself.

<u>NCC</u>: Reported that one NCC naval unit has been sanctioned to our college by the Central Government. This adds additional reputation to the college.

**Beautification of college Campus:** Under beautification of college campus scheme, a lawn has been created in the open place opposite to principal's room. Plant along the Paver Block pathway from the main entrance also have been planted. New plants have been also planted inside the college chapel compound. For the benefit of the students to sit during the free hours stone benches has been erected in different places of the campus. The boys two – wheelers shed has also been extended with the support of PTA.
